Agreements Services Branch (ASB) is part of MRPBS's Financial Services Branch, Financial Management Division. ASB provides operational support to headquarters, develops agency agreements policy, delivers quarterly agreements meetings and training, administers the ezFedGrants system and ACMS Agreements Inventory, and provides technical guidance to agency field personnel.

The types of agreements for which the ASB is responsible includes Federal financial assistance (cooperative agreements and grants), cooperative service agreements (trust funds and reimbursables), interagency agreements, memoranda of understanding, cooperative arrangements, and technology transfer agreements (cooperative research and development agreements, material transfer agreements, and confidentiality agreements).
