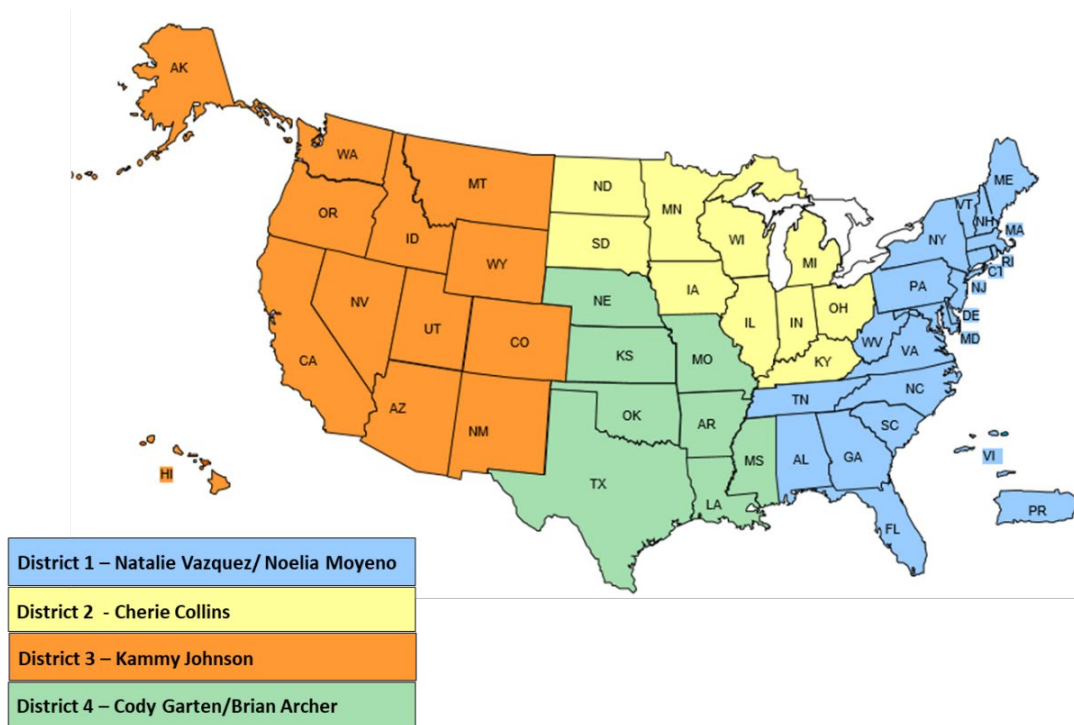


Need Assistance with Emergency Management Response System (EMRS)?
